## **RESPONSIBILITIES**

- Support Quality Measure Development and Maintenance
  - Conduct literature reviews and synthesize relevant clinical information to assist with decision-making
  - Conduct quantitative data analyses to support measure testing using administrative claims and other data sources, and present interpretations of results to internal and external audiences
  - Support measure specification and value set (e.g., National Drug Code, ICD-10)
    creation and maintenance
  - Summarize measure development and maintenance information such as subject matter expert input, clinical guidelines and literature, and quantitative testing results

- Provide technical assistance to PQA measure users by explaining measure logic, rationale, etc.
- Support PQA Stakeholder Engagement
  - Support the recruitment and engagement of PQA panels by drafting materials, reviewing applications, and corresponding with applicants and members via email
  - o Create agendas, slides, and other information for webinars and convening events
  - Support the execution of webinars and convening events by presenting content, coordinating quality assurance, and other related tasks
  - Engage with PQA members and other stakeholders via email, virtual meetings, and in-person at PQA events, as appropriate
